## BOARD BRIEFS

### Regular Meeting — Thursday, Dec. 15, 2016

*Board Briefs is a summary report of the Board of Education's meetings prepared by District 130 Communications Supervisor Amanda Siegfried. It is not intended to be an official transcript of the meeting.*

**Note:** Board Members Tomas Almazan and Nicole Rodriguez were absent.

#### Action Items

- Tax Levy Resolutions: The board voted unanimously to approve the Property Tax Levy for 2016 as presented and the associated resolutions.
- Life Safety Survey: The board voted unanimously to approve the proposal from Themes Architecture to conduct a 10-year Life Safety Survey, which is required by the Illinois State Board of Education. The last survey was completed in 2006.
- Summer Life Safety Projects: The board voted unanimously to approve the scope of the projects proposed for the summer of 2017. The estimated cost of the projects is approximately \$870,240. They include roof section replacements at Kerr Middle, Nathan Hale Intermediate and Lincoln schools, as well as a chiller replacement at Lincoln School.
- Student Tour Services RFP: The board voted unanimously to approve Tour Services, Inc., Brightspark Travel and Worldstrides Travel to provide student tour services for approved field trips requiring a coach-style bus.
