Regular Meeting — Thursday, Feb. 16, 2017

Board Briefs is a summary report of the Board of Education's meetings prepared by District 130 Communications Supervisor Amanda Siegfried. It is not intended to be an official transcript of the meeting.

Action Items

- District 128 Withdrawal from Eisenhower Cooperative: The board voted unanimously to approve a resolution approving the petition for withdrawal of Palos Heights School District 128 from the Eisenhower Special Education Cooperative, effective July 1, 2017, and the withdrawal agreement.
- Service Employees' Contract: The board voted unanimously to approve a contract with the Service Employees' International Union Local 73, CtW, CLC, effective July 1, 2016, through June 30, 2019.
- Board Policy Manual Amendments/Revisions: The board voted unanimously to adopt the policies appended to the memorandum dated Jan. 6, 2017.
