Regular Meeting — Thursday, June 16, 2016

Board Briefs is a summary report of the Board of Education's meetings prepared by District 130 Communications Supervisor Amanda Siegfried. It is not intended to be an official transcript of the meeting.

Administrative Hires/Appointments

- Nathan Hale Intermediate Principal: The board voted unanimously to approve the employment of Churchill Daniels Jr. as the new principal of Nathan Hale Intermediate School. He will assume his position on July 1, 2016. [His biography can be viewed on the district website.](#)
- Veterans Memorial Assistant Principal: The board voted unanimously to approve the appointment of Donald Jones as the assistant principal of Veterans Memorial Middle School. Mr. Jones has successfully served as the interim assistant principal of the school for the past eight months.
