## BOARD BRIEFS

### Regular Meeting — Thursday, March 16, 2017

*Board Briefs is a summary report of the Board of Education's meetings prepared by District 130 Communications Supervisor Amanda Siegfried. It is not intended to be an official transcript of the meeting.*

**Note:** District 130 Board President Anne Rapp announced her resignation, effective Friday, March 17. Per Illinois School Code, the Board of Education will fill the vacancy through appointment.

**Unfinished Business:** The Board of Education was provided new and updated documents related to the district's volunteer procedures. Those documents will be shared with staff and families, and will be posted to the district website.

#### Action Items

- **Administrator for Business Services:** The board voted unanimously to approve the employment of Michael Gallagher as the Administrator for Business Services, effective July 1, 2017.
- **Preparation of Tentative Budget:** The board voted unanimously to designate the Administrator for Business Services to prepare a tentative budget for the fiscal year beginning July 1, 2017, and ending June 30, 2018.
- **Life Safety Projects:** The board voted unanimously to approve the base bid from the Lombard Company for 2017 Life Safety Projects.
- **Working Cash Fund Abatement:** The board voted unanimously to adopt a resolution authorizing the abatement of \$1 million from the Working Cash Fund to the Operations and Maintenance Fund to fund capital projects occurring during the summer.
- **Non-Renewal of First-Year Teaching Contract:** The board voted unanimously to adopt a resolution authorizing the non-renewal of teaching contracts for certain first-year teachers.
- **2017-18 School Calendar:** The board voted unanimously to approve the school calendar for the 2017-18 school year.
- **Other items approved in consent:**
